Discussion:

• Discussion of Debora Flynn filling the role of the Church Representation.

All in Favour. Motion Carried.

Motioned by Gabriela Sabau to accept the Nominating Report.

Seconded by Tracy Vallis. All in Favour. Motion Carried.

8. FINANCIAL COMMITTEE REPORT

Kerry Hutchings announced a minor change to the 2022 Financial Report. A motion was made to accept the 2022 Financial Report, with minor clarifications to the numbers.

Motioned by Kerry Hutchings. Seconded by Carolyn Buckle.

Presentation by Kerry Hutchings:

- We had a great financial year.
- Kerry clarified an error in the report. The Baptist Foundation Interest is not \$0.00 but is \$7.126.26.
- Total Income is now \$263.976.28.
- Total Expenses are now \$236,155.53.
- Net Income is now \$27,820.75.

Discussion:

- Group discussion about Baptist Foundation interest and Royal Bank interest.
- Thank you and appreciation for Tracy Vallis

and Debora Flynn.

- We discussed unexpected expenses, such as the sewer and the parsonage maintenance. Pastor Mitchell Foley arranged for a contractor to fix the crack in the foundation, repair the wall, and replace the carpet.
- We discussed how money was saved on rentals.
- Nobody was sent to the Convention, so the money was redirected to CBBC's Fall Retreat.
- Kerry Hutchings discussed how there could be a continuous improvement for the Finance Committee, such as meeting more often and reducing bank fees.
- Kerry Hutchings discussed Tithe.ly and envelopes. All information must be filled in on the donation envelopes to help the Teller volunteers.
- Kerry Hutchings discussed how the Convention money was redirected and how in the future, if you are spending money, you need to be familiar with the budget, such as when submitting an invoice, write the line item from the budget for the item Tracy Vallis mentioned asking Pastor Mitchell Foley if you need clarification about what number something is.
- Discussion on how Pastor Mitchell Foley introduced ChurchTrac. Stephanie Hutchings is enjoying ChurchTrac, and they are setting up tax receipts to be automatic.
- Tracy Vallis discussed the new payroll system, Wagepoint. Tracy updated us about the benefits of Wagepoint, such as how direct deposits are automatic, T4s, deductions, and tax slips. Wagepoint is also a reasonable price. The program is all online, straightforward, and faster.

Debora Flynn discussed how "Missions - Other" was not paid out. The church had a budget of \$5,000. This was an oversight. She thinks the money should go ahead and be donated.

Discussion:

- Kerry Hutchings mentioned it is the Deacon's decision on how to allocate this money.
- Gabriela Sabau attended a Food First meeting, and the demand for food dramatically increased. The organization needs help supplying enough food to those in need. Gabriela asked if we could increase the contribution to the Food Bank since

it is a special year because of inflation.

- We discussed what organizations CBBC supports, which include the Food Bank, Crandall University, Hands Across the Sea, Acadia University, and Canadian Baptist Ministries.
- Stephanie Hutchings gave an update about Hands Across the Sea in Haiti. Funds are being redirected to food since children are having barriers to going to school because of gang violence.

Ken Jacobsen called the question to approve the Financial Committee Report. All in Favour. Motion Carried.

David Buckle celebrated the faithfulness of giving in the church and how God has blessed us.

The 2023 budget was passed in the Fall.

Ken Jacobsen asked if there were any other related motions.

Motion by Gabriela Sabau that we double the contribution to the Food Bank for this year. Seconded by Carolyn Buckle.

Discussion:

- Tracy Vallis asked if we should start fresh or double up last year. Different options were discussed.
- Ken Jacobsen clarified we would be giving the \$5,000 budgeted for last year and the \$4,000 budgeted for this year to the various organizations we support.

Discussion:

- Pastor Mitchell Foley discussed how for next year, Gabriela Sabau missed the meetings and asked we would have subcategories explaining what how we could better adapt the constitution and how much each organization will receive. to our needs. - Debora Flynn mentioned we need to create a designated building fund for tax purposes. If we keep the money in our savings fund, we could lose our status as a charity. The group discussed this in more detail.
- We discussed the church's emergency fund. Kerry Hutchings mentioned there is \$50,000 in the bank.

All in Favour. Motion Carried.

10. ADOPTION OF NEW CONSTITUTION

Motion by David Buckle to adopt the new constitution.

Seconded by Tracy Vallis.

Discussion:

- Pastor Mitchell Foley explained the amending process to adapt the Constitution to our needs. He discussed how the motion is to adopt the constitution as is and have the committee review input and bring it to the Deacons.
- Carolyn Buckle mentioned how statements of faith should be included, such as beliefs about marriage. She will accept the constitution if it is a working document.
- The deadline is discussed (March 2025).
- More discussion about how we need a foundation for our constitution, but we can change and adapt.
- Brian Hoskins led a discussion on how the church needs protection (social status) around life, marriage, and work. He discussed how this document might one day end up in court.
- Discussion about the Governance Review Committee.

All in Favour. Motion Carried.

REPORT **OF THE** LEAD PASTOR

IN THE BEGINNING

The beginning of the

year started in the beginning—no, I'm not being clever. We began with a sermon series in the book of Genesis. Genesis 1 emphasizes that God created or determined the roles and functions of everything in the cosmos. God is powerful over the forces of chaos and brought order out of chaos.

Genesis 1 describes how God creates time, weather, and agriculture. God called them good. However, they may not feel good as we live under the curse. Time flies by fast, and it gets more quickly each year. The weather does not cooperate, and there are always stories of weather disasters worldwide. Food security is a current issue. Imagine how everything worked together in the original creation as they should, but now they have become forces we struggle against. These things define our existence but are beyond our ultimate control.

The story's peak is when the human race is made in the image of God. We can serve God and represent him on earth. Sin hampers our ability to do so, but through Jesus, God's image is restored in us. Every person has dignity, but life only makes sense if centred around God. That is what the creation story is all about. God rests on the seventh day, meaning he settles into the world he made as the sovereign ruler. We worship a God who still rules today.

SO THAT YOU MAY KNOW


We jumped from the Old Testament to the New by looking at the theme of the Assurance of Salvation from the book of 1 John. If you have walked with God for any length of time, doubts can arise,

and you begin to question your salvation. Our salvation is based objectively on Jesus Christ, the eternal Son of God. Then, John gives us three tests by which to examine our lives.

First, the test of righteousness, which is striving to obey the commands of God. The second test is the test of love towards other believers. The third test is the test of belief in the message of the good news of Jesus. Think of it this way: if you desire to obey God, you care about other believers, and you see the importance of guarding the truth against error, then God must be at work! Be encouraged!

Easter arrived! Jesus rose from the dead!



THE SEARCH FOR GOD CANNOT WAIT

There are some tough questions about Christianity. "What is Truth?" Simply put, "Truth is telling it like it is." Truth matters when it comes to life's significant issues. "Does God exist?" We examined the evidence for God from creation and design. We are told that as high as the heavens are above the earth, so great is God's love towards those who worship him (Ps 103:11).

Just as important, the sense we have of right and wrong points to the existence of God. Moral law implies a moral lawgiver. Without an absolute moral law, there could be no human rights or true justice. The Christian faith begins at the top with God.

The New Testament is historically reliable and

can be trusted. Jesus truly is the only way to God. God works in the world so that those who would respond to the gospel can hear it and respond (Acts 17:24-28). What about suffering? I'm sure this is one in our minds—how could a good God allow so much suffering? However, suffering makes sense in the Christian story. The chief purpose in life is not happiness but to know God. Sometimes, God can only get our attention through suffering. One day, he will rid the world of suffering.



CHILDREN'S AND YOUTH MINISTRY

"BACK IN MY DAY..."

This phrase is usually said by us older folks (Yes... this now includes me) to emphasize the fact that the world is changing. The problem with change is that it usually happens almost undetectably; so slowly that we can be left to lament a past simplicity that we didn't even realize was eroding.

The children and youth of today live in a world vastly different from the one we knew. It is sometimes difficult for us to understand how complex it has become. This is why many of our ideas and paradigms concerning Next Generation Ministry have to be re-examined. At Corner Brook Baptist, with the Holy Spirit's help, we are trying our best to ensure that our kids and youth are introduced to Jesus and are discipled within a loving community of faith.

SUNDAY MORNING CHILDREN'S **MINISTRY**

Most of our children's ministry occurs during the preaching portion of our Sunday Morning Service. Since September, we have seen our kid's ministry go from 4 or 5 on a Sunday to upwards of 16 children, and we are thankful for the influx of young families and children we get to serve. One fun addition to our Sunday Mornings is a robot named Stanley. Stanley helps us take up the offering, which is used to help Shinchayna, our sponsor child in Haiti, through Compassion Canada. So far this year, our children have had the chance to write Shinchayna and are looking forward to getting to know her better.

During the Sunday morning teaching time, our Kids Ministry breaks into three groups: Nursery, Preschool, and Elementary. Debora Flynn and her volunteers do a fantastic job caring for the nursery and preschool portions. You can read her report elsewhere in this booklet.

We have also adopted a new logo for the Kid's Ministry. The design includes a compass. We decided on this because our job is to help point our kids in the direction of Christ. We hope to incorporate this into T-shirts and branding in the near future.

I also want to mention that our Sunday Morning Kid's Ministry would not be possible without the help of our youth. They serve every Sunday morning and have become outstanding examples to the children that attend.

YOUTH MINISTRY

We decided to try something different in September with our Sunday morning youth ministry. Our youth meet at 10:00 am for breakfast, bible study, and a time of discussion. This time is led by Robert Hengeveld and gives the youth a chance to build relationships and connect.

We have also had a number of events throughout the year that are designed to build much needed community among our teenagers. These events have included a Nerf competition, a movie night at Steve and Lee-Ann Belfry's house, events at various homes, and rallies with other youth groups in town.

NURSERY & PRESCHOOL

In 2023, we were able to split this group into a nursery for ages 0–2 years and a preschool class for ages 3-4 years.

The nursery has an average attendance of 3-4 children, although there have been about 8-10 children that have attended over the past year. As nursery workers, we get to play, read stories, colour, teach sharing, or simply cuddle these little ones. It is a blessing to the workers, the children, and certainly to the parents who get to attend the service upstairs.

The preschool class has an average of 2-3 children, but there have been 5-6 children that have attended over the past year. During the Spring of 2023, we concentrated on Galatians 5:22-23 - The Fruit of the Spirit. It is amazing how they soak it all in, with the understanding of these bible truths. CHRISTMAS OUTREACH

During the Christmas season, we helped people experiencing homelessness in the city. We wanted to bless 23 homeless people in Corner Brook who were housed in a hotel. They included 18 males, three females, and one elderly couple.

Thank you to everybody who donated. I feel so blessed to be part of such a generous church. We raised \$1,547 in cash donations and received around 300 donated items. The requested items were shampoo, deodorant, body wash, chocolates, juice, toothbrushes, toothpaste, socks, hats, gloves, Tim Horton Gift Cards, and panty liners. We bought extra items for each bag, such as blankets, grocery gift cards, extra winter gear, Pajamas for the elderly couple, and various food items. Another item we added was a bible and an invitation card to join our services.

STUDENT FELLOWSHIP BREAKFAST

In 2023, the Student Breakfast ministry ran each Wednesday from January to April, and September to December. It has been a blessing for both students and volunteers.

Every Wednesday morning, a volunteer crew meets at 6 am to set up the downstairs space and prepare breakfast. The menu changes each week: toutons, pancakes, breakfast burritos, hash browns, beans, 'gloatmeal' (fancy oatmeal), eggs, and of course lots of salty breakfast meat: bacon, ham, sausage, and that Newfoundland favorite, bologna. In Fall 2023, we had many students from Japan coming regularly, so we even took a shot at serving rice and miso soup. Around 6:30 volunteers start transporting students from the 'flags' at Grenfell Campus to the church, and the breakfast itself is served from 7-8. After a time of informal visiting, we have a 'check-in' where attendees have a chance to introduce themselves. say where they are from (there are usually many international students), and make an observation or comment. We end our program with a teaching video from the Bible Project, and then transport students back to campus in time for early morning

classes. Every week, a clean-up crew cleans the dishes and puts the kitchen back in order.

Our purpose is not just to feed students (though the value of giving them with a nutritious meal shouldn't be underestimated), but to provide a meaningful experience of hospitality, fellowship, and Christian community. Our amazing volunteers don't just make food; they open their hearts to students, and I am very grateful for their service. Thank you, Carol Lim, Jean Rex, Christina Hartwig, Gordon Hartwig, Pastor Dan Bursey, Pastor Mitchell Foley, Robert Hengeveld, Larry Osmond, Steve Belfry, Nathaniel Amoah, Scott Armstrong, Ally Armstrong, and Kerry Hutchings. And special thanks to Joanne Deluney for sending along wonderful baked goods and treats for the students; it is deeply appreciated.

UPDATES

- The new building in the expansion is almost complete except for the water hook-up. The well is drilled. NorthEast Well Drilling will be onsite in early Spring to install and hook-up the pump to the building for running water. We had Tex's Trucking hired to dig the required ditch for NorthEast Well Drilling as they were set to arrive on February 7, 2024, but the ground is frozen, and they were unable to dig.
- February 13, 2024, Curtis Power installed the pole for NL Power to hook up electricity to the new building.
- The new Columbarium is due to arrive in about 2 months. The shipping cost is a lot, so Nelson Granite said they will hopefully have orders to come to NL so we can share the shipping. The estimated cost of shipping for the Columbarium alone would be approximately \$17,000 plus tax.
- Had Tex's Trucking in to move some snow as it was piling up and the plow on the truck was unable to lift and move it. They also cleared snow in the expansion.
